TERMS OF MEMBERSHIP AGREEMENT- AUTOMATIC MONTHLY WITHDRAWAL

I do hereby agree of my own free will to the terms of this contract entered into between myself and Balance Healing Center, (hereafter BHC). For the consideration of 3 months 5 months 10 months, beginning on today's date and valid through 3 months 5 months 10 months, of Membership at BHC, at 7646 W Touhy Ave, Chicago, IL 60631, I agree to pay BHC, or its agents and/or heirs the sum of \$72 \$70 \$66 per month for 3 months 5 months 10 months. I understand that I will be responsible for this charge regardless of how often I utilize this Membership. I understand that this Membership at BHC may not be used by any other person or persons and that I am solely responsible for its use. I agree that BHC, its agents or heirs may at anytime, for any reason, cancel this contract and/or Membership verbally or in writing.

Membership entitles me to:

- 3 monthly, 1-Hour Treatments (\$80 Value) for \$72
- 5 monthly, 1-Hour Treatments (\$80 Value) for \$70
- 1 gift certificate for a 1-Hour Treatment (\$80 Value) for \$70
- Unlimited infrared sauna use
- 5% off additional treatments
- 10 monthly, 1-Hour Treatments (\$80 Value) for \$66
- 2 gift certificates for a 1-Hour Treatment (\$80 Value) for \$66
- Unlimited infrared sauna use
- 5% off additional treatments
- 5% off additional gift certificates

Deposit of \$0 \$70 \$132 required and first months payment of \$72 \$70 \$66 will be charged today. An automatic withdrawal of \$72 \$70 \$66 will be deducted from the account I supply to BHC or its agents for each of the next 2 months 4 months 9 months from today's date.

Any service totaling \$80 or less is valid to be redeemed as the monthly treatment. Any service totaling less than \$80 will not be refunded or applied to future services. Membership benefits do not carry over to following months or other people. Unused treatments will not be refunded. Service must be received within the month.

Upgrades or services over \$80 are available for an additional fee at the time of service. Additional fee is cost of upgrade less \$80.

Sauna use is based on availability.

The 3 month, Taste of Balance Membership, is available only once per customer and is not renewable.

A credit/debit card number must be supplied when purchasing a membership.

If I terminate this contract for any reason during the membership I must reimburse BHC for all discounts received as a result of membership even if monthly services were not used. This fee will be drawn from the card used at sign up.

Memberships automatically cancels after the 3 month 5 month 10 month agreement.

For cancellation, holds, or changes to membership for any reason, member must notify BHC via e-mail at aimee@balance4healing.com at least 15 days prior to next auto draft. Please put "Membership" as subject heading of e-mail. In turn, BHC will send a confirmation via email after the changes have been made to the account.

I, my heirs, or my legal representatives forever release, waive, discharge and covenant not to sue BHC, its agents, or heirs for any injury, damage, or death caused by their negligence or any other act. BHC agrees to keep all financial information provided by me confidential and not share it with anyone except for the purposes enumerated in this contract.
